RULES FOR TEAM COMPETITION

1. First rider completes one full lap and delivers Rubber Check to second rider.
2. Second rider rides to the east barrier line, rider must be dismounted and free from his horse before they cross the east barrier line. He then runs to the ATV and hands off the baton.
3. ATV makes 1 ½ laps and stops in the designated area, dismounts, and gets into the wheelbarrow. Wheelbarrow cannot move until the rider is in the wheelbarrow.
4. Wheelbarrow driver pushes the wheelbarrow and ATV driver across the infield to the finish line. Pusher must hold on to the wheelbarrow at the finish line.
5. ATV requirements: Must be a 250 cc 2 stroke maximum, or a 450 cc 4 stroke maximum.
6. Wheelbarrows will be furnished by the committee. Any defects must be pointed out to the committee before your race starts.
7. All contestants will be observed for fairness and appropriate penalties will be levied.
8. Ruling of officials will be final. (JUDGES RULING IS FINAL)
9. All entries must be turned in with a \$50 entry fee and list participants by 7:00, ahead of the drawing on August 6th, 2021.
10. All teams will be qualified for quarter finals by times. The 8 fastest qualifiers will advance. The order they run will be the order they ran in qualifications. EX: 1st two qualified teams make up quarter-finals heat 1, etc.... There will be 4 quarter-final heats. Each individual team member will be timed in the trials and the fastest times will be paid 5 places as follows:
1st & 2nd Horse Riders: 1st-\$250 2nd-\$200 3rd-\$150 4th-\$100 5th-\$50
ATV and Wheelbarrow: 1st-\$250 2nd-\$200 3rd-\$150 4th-\$100 5th-\$50
11. All quarter-final winners will advance to the championship bracket, and all losers go to the consolation bracket. Semi-final winners in the championship bracket will run for 1st and losers will run for 3rd. Semi-final winners in the consolation bracket will run for 5th and losers for 7th.

12. All quarter-final, semi-final, and final heats will be redrawn for lane position.
13. Prior to the race, only team captains will participate in a rider meeting with the committee and judges to go over rules.
14. All above entrants agree to hold Scottsbluff County AG society and the Rubber Check Race Committee non-labile for any physical property damage or personal injury. Participants are acting at their own risk and must be at least 16 years of age.
